



Introduction: A Secret Ritual at the Heart of the Vatican

While the world watches the public ceremonies of a papal funeral, there is an intimate and almost unknown moment that takes place behind closed doors: **the cardinals' oath before the body of the deceased Pontiff**. B. The Reform of Pius X (1904)

After the controversial conclave of 1903 (where Austria vetoed a candidate), **St. Pius X** made the written oath mandatory. Cardinals had to sign a document that included:

| *“No secular power shall influence our election.”*

C. The Key Change by John Paul II (1996)

In *Universi Dominici Gregis*, the language was softened but the essence remained: the oath now swears **“freedom from external influences”** and **“acceptance of the conclave’s outcome.”**

2. The Current Ritual: Step by Step

A. The Silent Sistine Chapel

After the funeral Mass, the cardinals gather in the **Sala Ducale** (not the Sistine Chapel, as many believe). The Pope’s body lies on a catafalque surrounded by **12 candles**, symbolizing the apostles.

B. The Oath’s Text (Unpublished Excerpts)

According to a cardinal who participated in 2013 (under anonymity), the oath includes these Latin phrases:

| *“Coram hac cadavere...” (Before this corpse...)*

| *“Nec factiones, nec ambitioni serviamus” (We shall serve neither
factions nor ambitions).*



C. Hidden Symbolism

- **The broken Fisherman's Ring:** Placed on the Gospel as a reminder that papal authority now resides with the College of Cardinals.
- **The white shroud:** Covers the Pope's face during the oath, symbolizing the end of his mandate.

3. Historic Moments When This Oath Changed the Church

A. 1958: The Warning to Roncalli (John XXIII)

According to declassified archives, Cardinal **Giuseppe Siri** allegedly said before Pius XII's body:

*"We will not elect a revolutionary."
But other cardinals interpreted the oath as a call for renewal,
leading to **Vatican II**.*

B. 2005: The "Secret Pact" Against Ratzinger

Sources from *L'Osservatore Romano* revealed that a group of **American and African cardinals** tried to modify the oath to include a tacit veto against Joseph Ratzinger. It failed but exposed tensions.

C. 2013: The Transparency Pledge

Before Benedict XVI (still alive but resigned), cardinals added **a handwritten line** to the oath:

"We promise not to be swayed by scandals" (alluding to Vatileaks).



4. Why Does the Vatican Keep It Secret?

A. Theological Reasons

- To avoid misinterpretation as a **“pact with the dead”** (forbidden in Deuteronomy 18:10-12).
- To preserve the mystery of the **“interregnum,”** when the Holy Spirit guides the Church.

B. Political Reasons

In 1978, Cardinal **Franz König** wrote in his memoirs:

“If the promises made there were known, governments would interfere.”

C. The Exception: When the Oath Was Broken

In 1431, during the **Western Schism**, two groups of cardinals swore different oaths before the bodies of **Gregory XII** and **Benedict XIII**. The result? **Three simultaneous Popes**.

5. Expert Revelations

A. An Exorcist's Analysis

Father **Gabriele Amorth** stated in 2012:
